Ordinance #04-0207

AN ORDINANCE PROVIDING FOR THE ANNEXATION TO THE TOWN OF WARNER, OKLAHOMA, CERTAIN PORTIONS OF PROPERTY BELONGING TO MYRON G. AND ROBERTA McCALL;

IT IS ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WARNER, OKLAHOMA:

SECTION 1.

That Myron G. and Roberta McCall are the owners of the following described property situated in Muskogee County, State of Oklahoma, to-wit:

A tract of land situated in the N/2 of the NE/4 of the NE/4 of Section 29, Township 12 North, Range 19 East of the Indian Base and Meridian in Muskogee county Oklahoma, more particularly described as follows: Beginning 200.0 feet S 1 degrees 13'36" E of the Northwest corner of the N/2 NE/4 NE/4 ; thence S 1 degrees 13'36" E a distance of 461.08 feet to the southwest corner of the N/2 NE/4 NE/4 ; thence N 88 degrees 08'12" E along the south line of the N/2 NE/4 NE/4, a distance of 933.57 feet to the West right-of-way of the Old Midland Valley Railroad; thence N 30 degrees 59'40" W along the West right-of-way of the Old Midland Valley Railroad, a distance of 756.74 feet to the North section line; thence S 88 degrees 08'21" W along said section line a distance of 215.94 feet; thence S 1 degrees 13'36" E a distance of 200.0 feet; thence S88 degrees 08'21" W a distance of 344.90 feet to the point of beginning.

And that Myron and Roberta McCall has made a request to the Town of Warner, Oklahoma to annex said property and to extend the boundaries of the town to include said property.

SECTION 2.

The above described real estate adjoins the present Town limits of the Town of Warner, Oklahoma, and this Council finds that it is in the best interest of the said Town that the above described real estate be annexed to the Town of Warner, Oklahoma, and that the boundaries of the Town of Warner, Oklahoma, be extended to include said real estate.

SECTION 3.

That the real estate situated in Muskogee County, State of Oklahoma, described in Section 1 by the same is hereby annexed to the Town of Warner, Oklahoma, and the boundaries of the Town of Warner, Oklahoma, are hereby extended to include said real estate.

SECTION 4.

That this ordinance shall be in full force and effect after its passing and publication as required by law.
