

ORDINANCE NO. 09-01-01

AN ORDINANCE ANNEXING TO THE TOWN OF WEST SILOAM SPRINGS, OKLAHOMA, A CERTAIN TERRITORY HEREINAFTER MORE PARTICULARLY DESCRIBED; AND EXTENDING THE TOWN LIMITS OF SAID TOWN OF WEST SILOAM SPRINGS, OKLAHOMA, TO INCLUDE SAID TERRITORY; AND DECLARING AN EMERGENCY.

WHEREAS, the Board of Trustees of the Town of West Siloam Springs, Oklahoma, after public hearing has determined the corporate limits of the Town of West Siloam Springs, Oklahoma, should be extended to include the territory hereinafter more particularly described; and

WHEREAS, the Mayor and Board of Trustees of the Town of West Siloam Springs, Oklahoma, have found that the annexation of said territory is desirable and in the best interests of the Town of West Siloam Springs, Oklahoma, and that said property should be annexed to the Town of West Siloam Springs, Oklahoma.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE TRUSTEES OF THE TOWN OF WEST SILOAM SPRINGS:


Section 1: That the Corporate limits of the Town of West Siloam Springs, Oklahoma, be and the same are hereby extended to include the lands and premises, more particularly described as follows, to-wit:

See Exhibit "A"

Section 2: The lands and premises hereinbefore described are hereby annexed to the Town of West Siloam Springs, Oklahoma.

Section 3: The Plan for Services adopted by the Board of Trustees of the Town of West Siloam Springs, Oklahoma shall be completed within 120 months after the adoption of this Ordinance.

Section 4: That for the preservation of the public health, peace and safety of the citizens of the Town of West Siloam Springs, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall be in full force and effect from and after its publication and approval.







EXHIBIT A

A tract of land located in the NW ¼ of Section 27, Township 20 North, Range 25 East, Indian Base and Meridian, Delaware County, Oklahoma, being more particularly described as follows: Commencing at the NE corner of the NW ¼ of Section 27; thence S 89° 56' 20" West along the North line of Section 27, a distance of 867.58 feet to a point; thence S 00° 02' 25" East 779.98 feet to a set 3/8" iron rod, said point being the NW property corner and the TRUE POINT OF BEGINNING; thence N 89° 56' 20" East a distance of 215.14 feet to a set 3/8" iron rod; thence S 00° 01' 23" East a distance of 343.44 feet to a set 3/8" iron rod; thence N 89° 56' 20" East a distance of 53.00 feet to a set 3/8" iron rod; thence S 00° 01' 23" East a distance of 200.00 feet to a found 3/8" iron rod; thence S 89° 58' 20" West a distance of 487.33 feet to a set 3/8" iron rod; thence N 00° 02' 25" West a distance of 330.21 feet to a found 3/8" iron rod; thence N 89° 56' 20" East a distance of 219.35 feet to a found 3/8" iron rod; thence N 00° 02' 25" West a distance of 212.95 feet to the point of beginning.

AND

The South 115 feet of the following described tract of land: A tract of land lying in and being a part of the NE ¼ NW ¼ of Section 27, Township 20 North, Range 25 East, Delaware County, Oklahoma: Commencing at the NE corner of the NW ¼ of said Section 27; thence S 0° 01' 23" East along the East line NW ¼ a distance of 373.56 feet; thence S 89° 43' 07" West a distance of 370.00 feet to the TRUE POINT OF BEGINNING; thence continuing S 89° 43' 07" West a distance of 229.21 feet; thence S 0° 01' 23" East a distance of 950.21 feet to the South line of the NE ¼ NW ¼; thence N 89° 43' 07" East along said South line NW ¼ NW ¼ a distance of 229.21 feet; thence N 0° 01' 23" West a distance of 950.21 feet to the point of beginning.
