ORDINANCE NO. 10-06-01

**AN ORDINANCE ANNEXING TO THE TOWN OF WEST SILOAM SPRINGS, OKLAHOMA, A CERTAIN TERRITORY HEREINAFTER MORE PARTICULARLY DESCRIBED; AND EXTENDING THE TOWN LIMITS OF SAID TOWN OF WEST SILOAM SPRINGS, OKLAHOMA, TO INCLUDE SAID TERRITORY; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Board of Trustees of the Town of West Siloam Springs, Oklahoma, after public hearing has determined the corporate limits of the Town of West Siloam Springs, Oklahoma, should be extended to include the territory hereinafter more particularly described; and

**WHEREAS**, the Mayor and Board of Trustees of the Town of West Siloam Springs, Oklahoma, have found that the annexation of said territory is desirable and in the best interests of the Town of West Siloam Springs, Oklahoma, and that said property owned by Manuel Woolard and Jewel Woolard should be annexed to the Town of West Siloam Springs, Oklahoma.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE TRUSTEES OF THE TOWN OF WEST SILOAM SPRINGS:**


**Section 1:** That the Corporate limits of the Town of West Siloam Springs, Oklahoma, be and the same are hereby extended to include the lands and premises, more particularly described as follows, to-wit:

**Section 2:** The lands and premises hereinbefore described are hereby annexed to the Town of West Siloam Springs, Oklahoma.

**Section 3:** That for the preservation of the public health, peace and safety of the citizens of the Town of West Siloam Springs, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall be in full force and effect from and after its publication and approval.

**PASSED AND APPROVED** by the Mayor and Board of Trustees of the Town of West Siloam Springs, in special session on this 8<sup>th</sup> day of June, 2010, with emergency clause approved separately.


### Tract 1:

A tract of land located in the East Half of the East Half of the Northwest Quarter of the Northeast Quarter (E ½, E ½, NW ¼, NE ¼) of Section Thirty-six (36), Township Twenty (20) North, Range Twenty-five (25) East, Delaware County, Oklahoma, more particularly described as follows: Starting at the Northeast Corner of the said East Half of the East Half of the Northwest Quarter of the Northeast Quarter (E ½, E ½, NW ¼, NE ¼); thence West 165 feet; thence South 428 feet to the point of beginning; thence South 100 feet; thence West 165 feet; thence North 100 feet; thence East 165 feet to the point of beginning.

### Tract 2:

A tract of land located in the East Half East Half Northwest Quarter Northeast Quarter (E ½, E ½, NW ¼, NE ¼) of Section Thirty-Six (36), Township Twenty (20) North, Range Twenty-five (25) East, more particularly described as follows, to wit: Starting at the Northeast corner East half East Half Northwest Quarter Northeast Quarter (E ½, E ½, NW ¼, NE ¼), thence West 165 feet, thence South 528 feet to the point of beginning, thence South 792 feet to the point in the South line of said East Half East half Northwest Quarter Northeast Quarter (E ½, E ½, NW ¼, NE ¼), thence West along said South line 165 feet, thence North 792 feet, thence East 165 feet to the point of beginning.






