ORDINANCE NO. 136
AN ORDINANCE ANNEXING
CERTAIN REAL PROPERTY
TO THE TOWN OF WESTVILLE,
OKLAHOMA

BE IT ORDAINED by the Mayor and
Board of Trustees of the Town of West-
ville, Oklahoma:

SECTION 1. That the following
described real property situated adja-
cent to and abutting upon the present
corporate limits of the Town of West-
ville, Oklahoma shall be annexed to
and become part of the Town of West-
ville, Oklahoma, to-wit:

The East 830.00 feet of the NE 1/4 of
the NW 1/4 of the NW 1/4 of Section 5,
T-17-N, R-26-E, Adair County, Okla-
homa, containing 5.021 acres.

SECTION 2. That the boundaries of
the Town of Westville, Oklahoma are
hereby changed to correspond to the
legal description above given and that
the real property described is subject
to the right of way of Highway 62 on
the North side.

SECTION 3. That all ordinances or
parts of ordinances in conflict here-
with are hereby released.

SECTION 4. WHEREAS, an immedi-
ate necessity exists therefore, for the
preservation of public peace, an emer-
gency is hereby declared to exist by
reason whereof, this Ordinance shall
be in full force and effect from and
after its passage and approval and
publication:
