

ORDINANCE NO. 1467

AN ORDINANCE DETACHING FROM THE CORPORATE LIMITS OF THE CITY OF WOODWARD, OKLAHOMA, THE FOLLOWING DESCRIBED PROPERTY, TO-WIT:

A tract of land situated in the Northwest Quarter of Section Ten (10), Township Twenty-two (22) North, Range Twenty-one (21) West of the Indian Meridian described as follows: Beginning at a point on the section line 1232.33 feet South (S00°08'14"W) of the Northwest corner of said section; thence continuing South (S00°08'14"W) along said section line 689.48 feet; thence East (S87°19'22"E) 1285.56 feet; thence North (N00°08'14"E) 1419.33 feet; thence West (N88°53'41"W) 180.74 feet; thence South (S00°01'27"W) 704.46 feet; thence West (N88°22'51"W) 1103.28 feet to the point of beginning;

And

A tract of land situated in the Northwest Quarter of Section Ten (10), Township Twenty-two (22) North, Range Twenty-one (21) West of the Indian Meridian described as follows: Beginning at the Northwest corner of said Section ten (10); thence South (S00°08'14"W) 1232.33 feet along the boundary of said Section ten (10); thence East (S88°22'51"E) 641.90 feet; thence North (N00°08'14"E) 1246.16 feet to a point on the North boundary of said Section Ten (10); thence West (N89°36'54"W) 641.69 feet to the point of beginning,

AND DECLARING AN EMERGENCY.

Whereas, the Mayor and the Commission of the City of Woodward, Oklahoma deem it to be in the public interest to detach from the corporate limits of the City of Woodward the above described properties and that the retention of the above described properties within corporate limits of the City of Woodward is not in the best interests of the citizens of the City of Woodward, and to declare an emergency.

**BE IT ORDAINED BY THE COMMISSION OF THE CITY OF
WOODWARD THAT THE FOLLOWING DESCRIBED PROPERTY
SITUATED IN WOODWARD COUNTY, OKLAHOMA, TO-WIT:**



A tract of land situated in the Northwest Quarter of Section Ten (10), Township Twenty-two (22) North, Range Twenty-one (21) West of the Indian Meridian described as follows: Beginning at the Northwest corner of said Section ten (10); thence South (S00°08'14"W) 1232.33 feet along the boundary of said Section ten (10); thence East (S88°22'51"E) 641.90 feet; thence North (N00°08'14"E) 1246.16 feet to a point on the North boundary of said Section Ten (10); thence West (N89°36'54"W) 641.69 feet to the point of beginning,

**BE, AND THE SAME IS HEREBY DETACHED AND EXCLUDED
FROM THE CORPORATE LIMITS OF THE CITY OF
WOODWARD, OKLAHOMA.**

SEVERABILITY. The provisions hereof are hereby declared to be severable, and if any section, paragraph, sentence or clause of this Ordinance is for any reason held invalid or inoperative by any court of competent jurisdiction such decision shall not affect any other section, paragraph, sentence or clause thereof.



EMERGENCY. Whereas, it is immediately necessary for the preservation of the public health, peace and safety of the City of Woodward and the inhabitants thereof that the provisions of this Ordinance become operative immediately, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect immediately from and after its passage, approval and publication as provided by law.
