To the People of Oklahoma:

I am pleased to issue the December monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The Treasury curve flattened in December as the front end of the curve remained at historic lows and the long end saw yields decrease approximately 20 basis points over the month. As the markets ended the calendar year the Dow Jones Industrial Average (DJIA) was up, the Standard & Poor's 500 index was flat and the Nasdaq was down. The DJIA closed the year up 5.53%. The S&P 500 lost 0.04 point, the smallest annual change since 1947. The Federal Open Market Committee (FOMC) made no change to the federal funds rate range maintaining zero to 0.25%.

Economic Developments

Numerous reports were issued in December that affected performance of the markets during the month. The Institute for Supply Management reported that its index of manufacturing activity rose to 52.7 in November, the highest level since June. The unemployment rate for November dropped to 8.6% from 9.0% in October. US average hourly earnings slipped 0.1% and average hours worked were unchanged at 34.3. The producer price index (PPI) for finished goods in November rose 0.3%. Year-over-year, the PPI is up 5.7%. Retail sales in December increased 0.2% from the previous month. The consumer price index (CPI) for November was unchanged. The core CPI rose 0.2%. Year-over-year, the CPI is up 3.4%. The US trade deficit slipped 1.6% in October to \$43.5 billion, the lowest level of the year, after reaching to \$44.2 billion in September. The Conference Board's consumer confidence index in December unexpectedly shot up more than nine points to 64.5 from 55.2 in the prior month. This was the highest reading since April. The measure moved closer to its 5-year average of 65, but remains far from what is considered a healthy level, which is around 90. The Bureau of Economic Analysis estimated the real gross domestic product (GDP), the output of goods and services produced by labor and property located in the US, increased at an annual rate of 1.8% in the third quarter. Pending home sales for November rose 7.3%, to the highest level in 19 months after gaining 10.4% in the prior month. Year-over-year Pending Home Sales were up 6.9% in November. The National Association of Realtors (NAR) reported existing home sales for November increased 4.0% month-over-month to 4.42 million. The NAR also issued downward revisions to existing home sales data by an average of 14% since 2007, revealing a softer housing market than previously estimated. New home sales in the US dropped to 305,000 in 2011, the lowest since the Commerce Department starting keeping records. Sales peaked at 1.28 million in 2005. The average sales price of new homes was \$242,900 and there is an estimated 6.0 month supply of new homes at the current sales rate.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.46% in December and the weighted average maturity was 854 days. In terms of segment weightings, decreases in U.S. government sponsored enterprises were offset by a nearly equal increase in money market mutual funds. The year-to-date monthly average investable base remained flat at \$3.342 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 39% of the portfolio.

Mortgage-backed securities were 37%, municipal bonds were 2% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 10%, and OK Invest was 4%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,500,438,342 and State Agency balances in OK Invest at \$2,036,538,850 for a total of \$5,536,977,192.



In February 2011, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2012. The amount estimated was \$96,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison December 31, 2011

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$8,731.12. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
