To the People of Oklahoma:

I am pleased to issue the February monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

The Treasury market continued flat returns in February. The benchmark 10-year treasury fell from a monthly high of 2.14% to end at 1.99%. The 30-year increased by 48 basis points to 2.73%, but closed the month at 2.59%.

The three main stock indexes were up for the year. The Dow Jones Industrial Average ended at 18,132 with a 5.6% gain for the month. The S&P 500 closed at 2,104 and was up 5.5%, which reflected its highest monthly increase since October 2011. The NASDAQ made the biggest monthly gain at 7.1% and closed at 4,963.

The Federal Open Market Committee (FOMC) released its January 27-28 meeting minutes. The minutes displayed a cautious tone and sited a strong dollar, lackluster wage growth and slower growth overseas as potential problems for the economy. Janet Yellen testified on February 24 before the Senate Banking Committee. In her prepared remarks she stated that inflation remains a concern and the FOMC continues to be patient in regard to any interest rate increases.

Economic Developments

The unemployment rate increased 1/10th of a point to 5.7%, which was attributed to the return of previously absent job seekers to the labor force. The rate was still lower than the 6.6%, from the previous twelve months. The U.S. job openings climbed to 5.028mm in December from 4.972mm in November, as reported by the Labor Department. The recent job openings number represented the highest since 2011.

The Labor Department reported the January headline Consumer Price Index (CPI) fell 0.7% month-over-month, which was expected due to the decline in oil prices. The core CPI, ex food and energy, climbed 0.2% month-over-month, which reflected the largest core increase over the past three months. For the third straight month, the Producer Price Index (PPI) fell 2.1% and the core PPI also decreased by 0.2%.

The Census Bureau estimated retail sales dropped 0.8% in January after having declined 0.9% the previous month. Sales of clothing, furniture, department stores and grocery stores exceeded the increases in restaurant, building materials and electronics.

The National Association of Realtors reported that existing home sales in January declined 4.9% month-over-month and the median sales price of existing homes in the fourth quarter climbed 6% year-over-year to \$208,700.

The Gross Domestic Product (GDP) came in at 2.6% on a seasonally adjusted annualized rate, which was the first estimated report. The lower than expected headline number reflected decreases in net exports, federal government expenditures, non-residential fixed investments and a drop in business investment for equipment. An increase in petroleum imports lead to a growing U.S. trade deficit of \$46.6 billion, which was the widest since November 2012.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.85% in February and the weighted average maturity was 1,038 days. The year-to-date monthly average investable base was \$4.18 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 45% of the portfolio. Mortgage-backed securities were 42%, municipal bonds were 1% and Certificates of Deposit represented 3% of assets. Money market mutual funds and commercial paper sweep were 3%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 1%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,783,733,572 and State Agency balances in OK Invest at \$2,500,825,872 for a total of \$6,284,559,444.



In December 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2015. The amount estimated was \$58,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

February 28, 2015

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$1,612.27. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
