## OKLAHOMA STATE TREASURER

To the People of Oklahoma:

I am pleased to issue the November monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

### Market Conditions

Yields on U.S. Treasury securities increased minimally during November. The yield on the 10-year Treasury finished the month at 2.068% and the 30-year Treasury bond was 3.055%. The announcement by the Federal Reserve, European Central Bank and central banks of Japan, the U.K., Canada and Switzerland that they would cut the cost of tapping emergency dollar loans by half a percentage point sent the markets soaring on the last day of November. The Dow Jones Industrial Average (DJIA) recorded its biggest day of gains since March 23, 2009, jumping 490 points, and closed in positive territory for November. All 10 groups in the S&P 500 rose as gauges of financial, commodity and industrial shares added at least 5.1%. Commodities also rallied as crude oil rose back above \$100 a barrel. The Federal Open Market Committee (FOMC) held a two-day meeting in November. The Fed's statement following the meeting was largely unchanged from the September statement but was more optimistic noting that growth strengthened in the third quarter. The inflation outlook was unchanged.

### Economic Developments

Numerous reports were issued in November that affected performance of the markets during the month. The Institute for Supply Management reported that its index of manufacturing activity fell to 50.8 in October from 51.6 in September. The unemployment rate for October slipped to 9.0% from 9.1%. US average hourly earnings rose 0.2% and average hours worked remained 34.3. The producer price index (PPI) for finished goods fell 0.3% in October after rising 0.8% in September. Retail sales increased 0.5% in October. The strength was driven by a jump in sales in electronic stores, sporting goods and internet shopping. Overall consumer prices (CPI) were lower than forecasts, falling 0.1% in October. Core CPI prices rose 0.1% in October and the year-over-year core CPI inflation rate picked up to 2.1% from 2.0%. The trade deficit unexpectedly shrank to \$43.1 billion in September after rising to \$44.9 billion in August. The Conference Board's November consumer confidence index unexpectedly shot up more than 15 points to 56 from 40.9 in October. US 3<sup>rd</sup> quarter gross domestic product (GDP) rose 2.0%, revised down from a prior estimate of 2.5%. Existing home sales rose 1.4% in October. The median home price slipped to \$162,500 from \$165,800. Sales of new homes increased a modest 1.3% in October.

### Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 2.48% in November and the weighted average maturity was 914 days. Funds were shifted out of the money market mutual funds and invested in U.S. government sponsored enterprises during November. The year-to-date monthly average investable base was \$3.342 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 41% of the portfolio. Mortgage-backed securities were 39%, municipal bonds were 2% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 7% and OK Invest was 4%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

### Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

### Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages.

### Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,210,973,967 and State Agency balances in OK Invest at \$2,102,217,395 for a total of \$5,313,191,362.

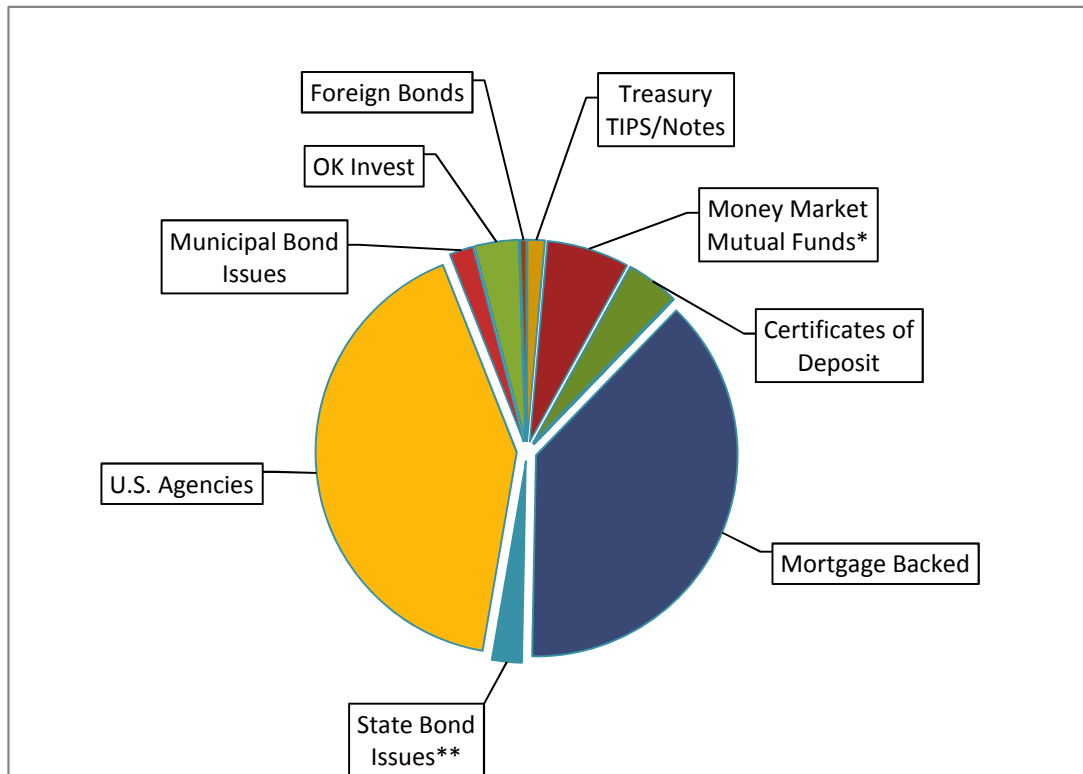

In February 2011, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2012. The amount estimated was \$96,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

# Explanation of Performance Comparison

## November 30, 2011

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.

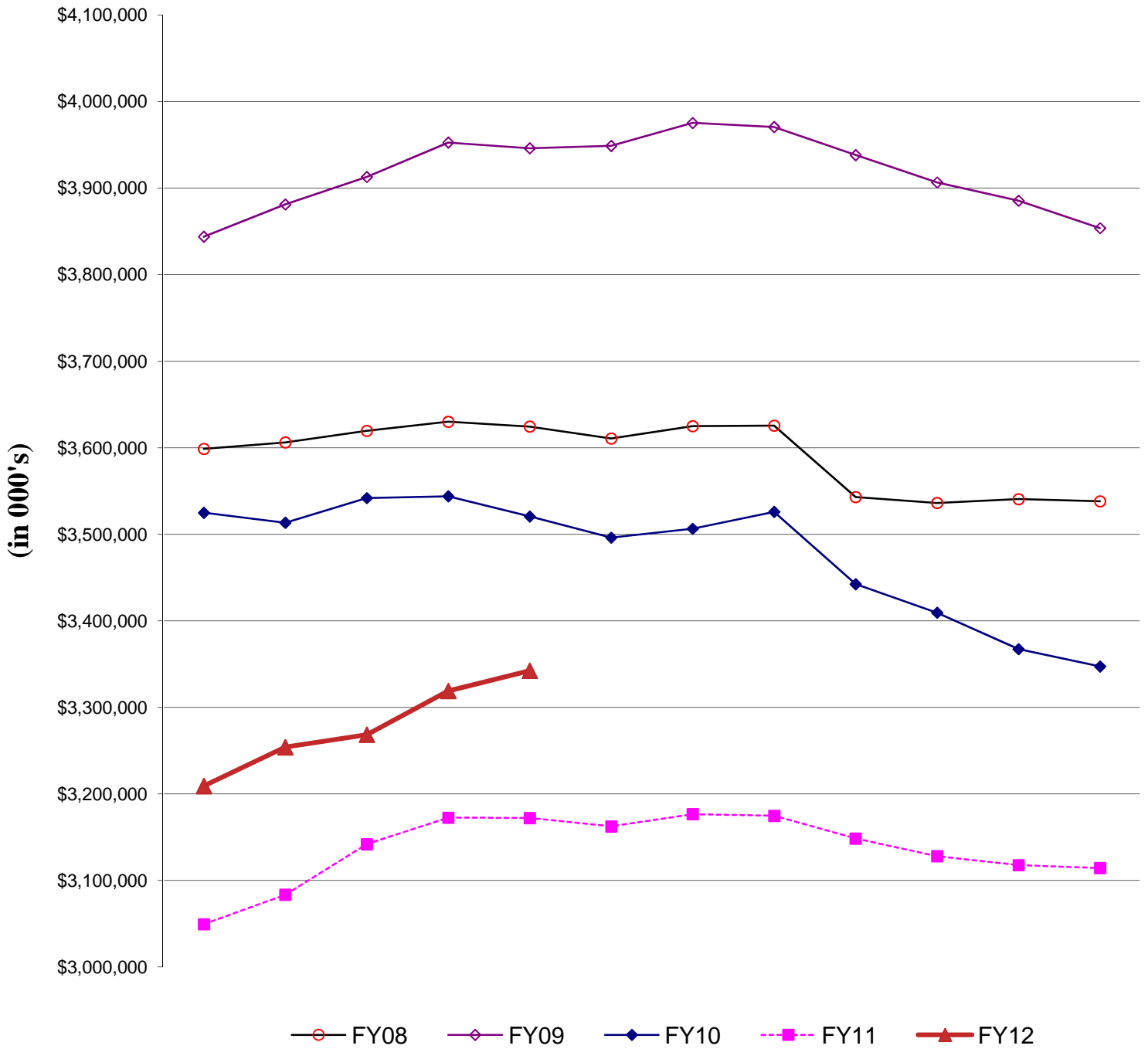

The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$7,160.83. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
