To the People of Oklahoma:

I am pleased to issue the October monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Treasuries on the short-end of the yield curve ended October higher with little movement in the long-end of the curve. The benchmark ten-year treasury ended the month at 2.38%, but the largest gain was in one-year and two-year treasuries coming in at 1.426% and 1.602% respectively. The thirty-year treasury was at 2.88%, increasing by 2 basis points from the beginning of the month.

Historic days of returns continued for the U.S. stock market with the Dow Jones industrial average closing above 23,000 for the first time on October 18. The S&P, Dow Jones and Nasdaq advanced in October ending the month at 2,575, 23,377 and 6,727, respectively. Returns for the year were up for the S&P, Dow and Nasdaq earning 15%, 18.3% and 25%, respectively.

The minutes from the September meeting of the Federal Open Market Committee (FOMC) reflected that all members were in agreement with beginning the implementation of balance sheet normalization and policy makers continued to ponder why inflation was still lower than expectations.

Economic Developments

The Bureau of Labor Statistics reported that the unemployment rate dropped to a sixteen-year low of 4.2% in September. Hurricanes Harvey and Irma were directly attributed to the first decline in non-farm payrolls in seven years, reflecting a loss of 33,000 jobs. In addition, July non-farm payrolls were downwardly revised from 189,000 to 138,000. Average hourly earnings jumped by an unexpected 0.5% month-over-month and 2.9% year-over-year and the labor force participation rate increased to 63.1%, the highest since March 2014.

The headline consumer price index (CPI) gained 0.5% month-over-month and core CPI rose by 0.1% over the month, with both slightly missing economist's expectations. On a year-over-year basis, headline CPI rose by 2.2% and core CPI by 1.7%. The producer price index (PPI) rose 0.4% and the core PPI, which excludes food, energy and trade margins increased 0.2%. The hurricanes affected the energy supply, which increased wholesale prices.

Retail sales for September increased 1.6%, slightly below expectations of 1.7%. The sales results were the biggest increase in two-and-one-half years. The rise was attributed to gains in car sales to replace vehicles that were damaged by the hurricanes and by a rise in the cost of gas, also due to the hurricanes. In addition, there were increases in retail store sales, restaurants and online-shopping websites. If gas and auto sales were deducted from monthly sales, the resulting outcome would have been weaker coming in at 0.5%.

According to the National Association of Realtors (NAR), total existing-home sales increased 0.7% to a seasonally adjusted annual rate of 5.39 million in September from 5.35 million in August. The sales results represented the second slowest over the past year, and was 1.5% below twelve months before. The slowdown

was attributed to diminished housing supply, especially in the lower priced market, and quickly increasing home prices. NAR reported that first-time home buyers were at 29% in September, compared to 34% a year ago. The gross domestic product (GDP), the broadest measure of goods and services produced in the U.S., rose by 3% in the third quarter. Economists were concerned about a lowered GDP due to hurricanes Harvey and Irma, which reduced business activity in parts of Texas and Florida in August and September. With the final second quarter GDP coming in at 3.1%, it was the first time since 2014 that the economy had consecutive quarters of at least 3% growth. The Bureau of Economic Analysis said that real GDP growth was supported by “positive contributions from personal consumption expenditures, private inventory investment, nonresidential fixed investment, exports and federal government spending”.

Portfolio Commentary: Performance, Diversification, and Strategy

The Treasurer’s portfolio yielded 1.74% in October with a weighted average maturity of 820 days. The year-to-date monthly investable base was \$3.15 billion, in comparison to \$3.19 billion a year ago. Portfolio diversification continues to be sound. U.S. government sponsored enterprises accounted for approximately 41% of the portfolio and Mortgage-backed securities were 38%. Municipal bonds were 1% and Certificates of Deposit represented 4% of assets. Money market mutual funds were 8% and OK Invest, which is comprised of various State agency funds, represented 6% of the total portfolio. State Bond Issues (at 1%), foreign bonds (less than 1%) and U.S. Treasury Inflation-Protected Securities (less than 1%) made up the balance of funds invested. In keeping with the State’s statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer’s investments at \$3,343,186,172 and State Agency balances in OK Invest at \$2,192,777,953 for a total of \$5,535,964,125.





These figures, which are dollar-weighted and time-weighted where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month.

To ensure the integrity of data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are held with the custodian bank Northern Trust Company.



SECURITIES LENDING PROGRAM

The State Treasurer participates in a Securities Lending Program with Northern Trust Company acting as lending agent. Northern Trust retains 15% of the revenues generated as compensation for services, their share for the month was \$1,406. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first 450,000.00 of Security Lendings revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.

NORTHERN TRUST CUSTODY FEES

Pursuant to a custodial contract with Northern Trust Company, custody fees are paid on a quarterly basis. Fees paid to Northern Trust Company for the first, quarter was \$11,250.
