To the People of Oklahoma:

I am pleased to issue the September monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

In September 5-year U.S. Treasury notes ended down at 1.38%, 10-year Treasuries fell to 2.61% from 2.62% and the 30-year bond yield was at 3.69%. The decline in bond yields was partially due to the prospect of a partial closure of the U.S. Government because of dissension over healthcare legislation and increasing the debt limit. The Dow Jones Industrial Average was down to end the month at 15,129. The broad-based S&P 500 declined slightly to 1,681, but was up 3% in September and up 18% year to date. The tech-rich Nasdaq Composite Index came in at 3,771. The Federal Reserve surprised the markets on September 18 by refusing to taper the \$85 billion monthly bond buying program. Fed Chairman Ben Bernanke said that a weaker economy than expected, higher U.S. interest rates and the possible fiscal showdown in Washington were key reasons that tapering of bond buying did not occur.

Economic Developments

The national employment report reflected that private sector employment added 176,000 jobs in August from July, with 165,000 jobs being created in the service sector. The service sector component that added the most jobs was professional/business services with 50,000 jobs added. Companies with 50-499 employees added the most with 74,000 jobs. The Institute for Supply Management (ISM) purchasing managers index rose to 55.7 in August from 55.4 in July. Out of the 18 business industry components which comprise the index, 15 illustrated expansions, 2 held unchanged, and 'miscellaneous manufacturing' was the only industry which contracted.

According to the Census Bureau, the cost of living rose 0.1% in August from July. The consumer price index (CPI), less food and energy costs, or core CPI, also rose 0.1%. Housing rents and medical care services led the increase in prices, while fuel and utilities costs decreased.

The Bureau of Labor Statistics reported the Producer Price Index (PPI) rose 0.3% in August, seasonally adjusted. The increased price of gasoline and the surge in cost of fresh vegetables attributed to wholesale prices for both energy and foods, which pushed up headline PPI for finished goods. Net of both energy and food, core PPI was unchanged during August.

The Census Bureau reported that sales of new single-family homes rose 7.9% in August from the month before to a seasonally adjusted annual rate of 421,000. The August increase in new home sales of 12.6% was higher

in comparison to twelve months before, which came in at 374,000. The median and average sales prices of new single-family homes were \$254,600 and \$318,900 respectively. The S&P/Case-Shiller Home Prices report reflected that prices in 20 major cities increased 12.4% in July compared to the same month last year. Prices were up most sharply in many of the Western and Southwestern markets that saw some of the biggest declines during the housing bust. The measure of contract signings to purchase a previously owned home declined for a third straight month, but remained 5.8% above year ago levels. The decrease in pending home sales can be attributed to the rise in mortgage rates.

The Bureau of Economic Analysis released a third estimate of the second quarter Gross National Product (GNP), which came in at 2.5%. This estimate matches the growth rate reported in late August. The biggest positive contributor to GDP growth was consumption, which added 1.24% to the measure. In related news, the Commerce Department said the U.S. current account balance fell nearly 6% to \$98.9B in the second quarter of 2013. The goods deficit, a component of the reading, declined to \$117.8B from \$122.6B.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.83% in September and the weighted average maturity was 1,256 days. The year-to-date monthly average investable base was \$4.015 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 41% of the portfolio. Mortgage-backed securities were 37%, municipal bonds were 2% and Certificates of Deposit represented 2% of assets. Money market mutual funds were 11%, and the allocable portion of sales and use tax to General Revenue collected by the Oklahoma Tax Commission was 3%. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on challenging and potentially volatile market conditions, portfolio strategy consists of a combination of laddered maturities and market observation for investment opportunities that will maximize income in a secure environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$4,195,159,008 and State Agency balances in OK Invest at \$2,437,696,832 for a total of \$6,632,855,840.



In February 2013, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2014. The amount estimated was \$86,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison September 30, 2013

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securitiet Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$4,514.01. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
