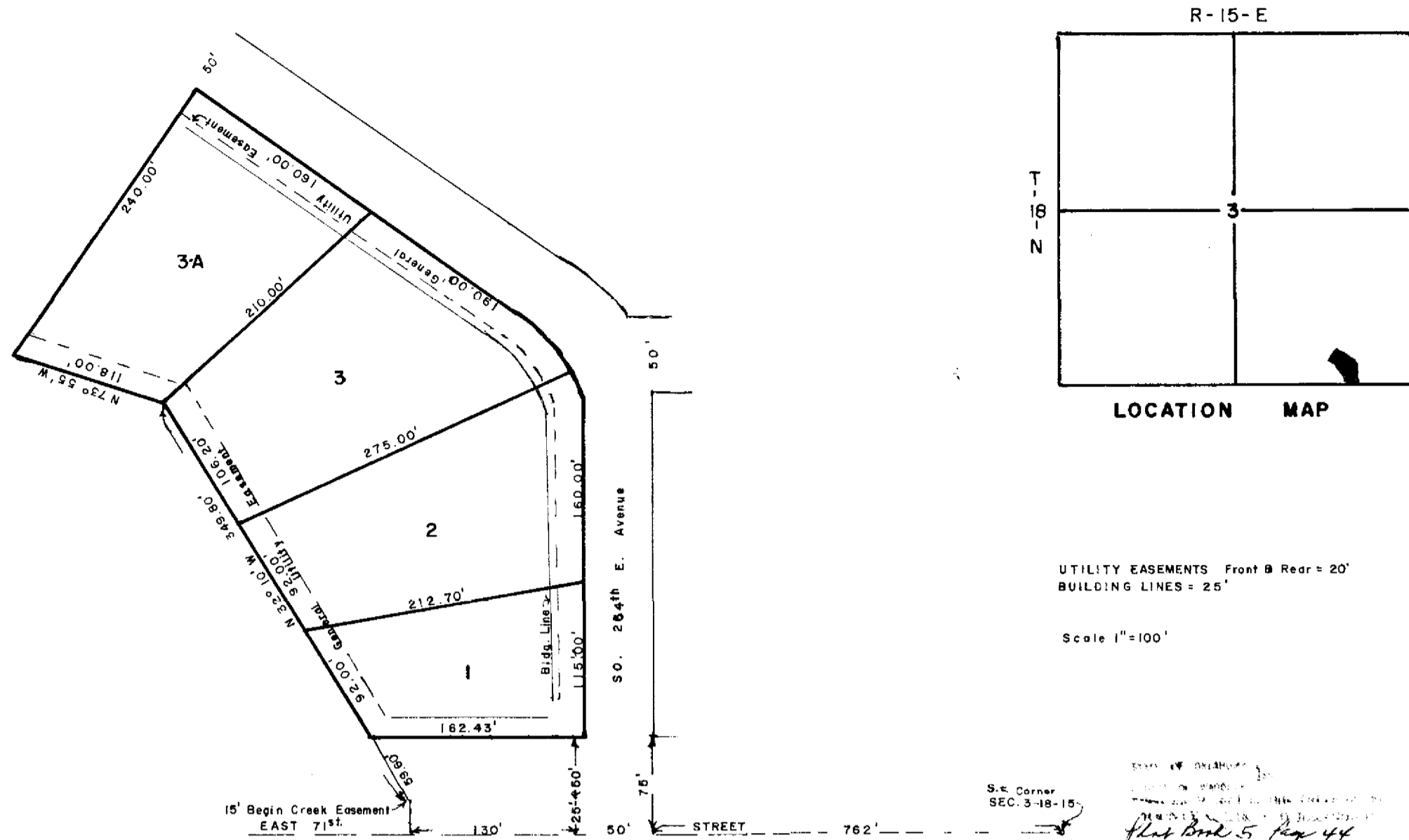


AMENDED PLAT OF LOTS 1, 2, and 3, AND OF CORRECTED PLAT OF LOT 2 of

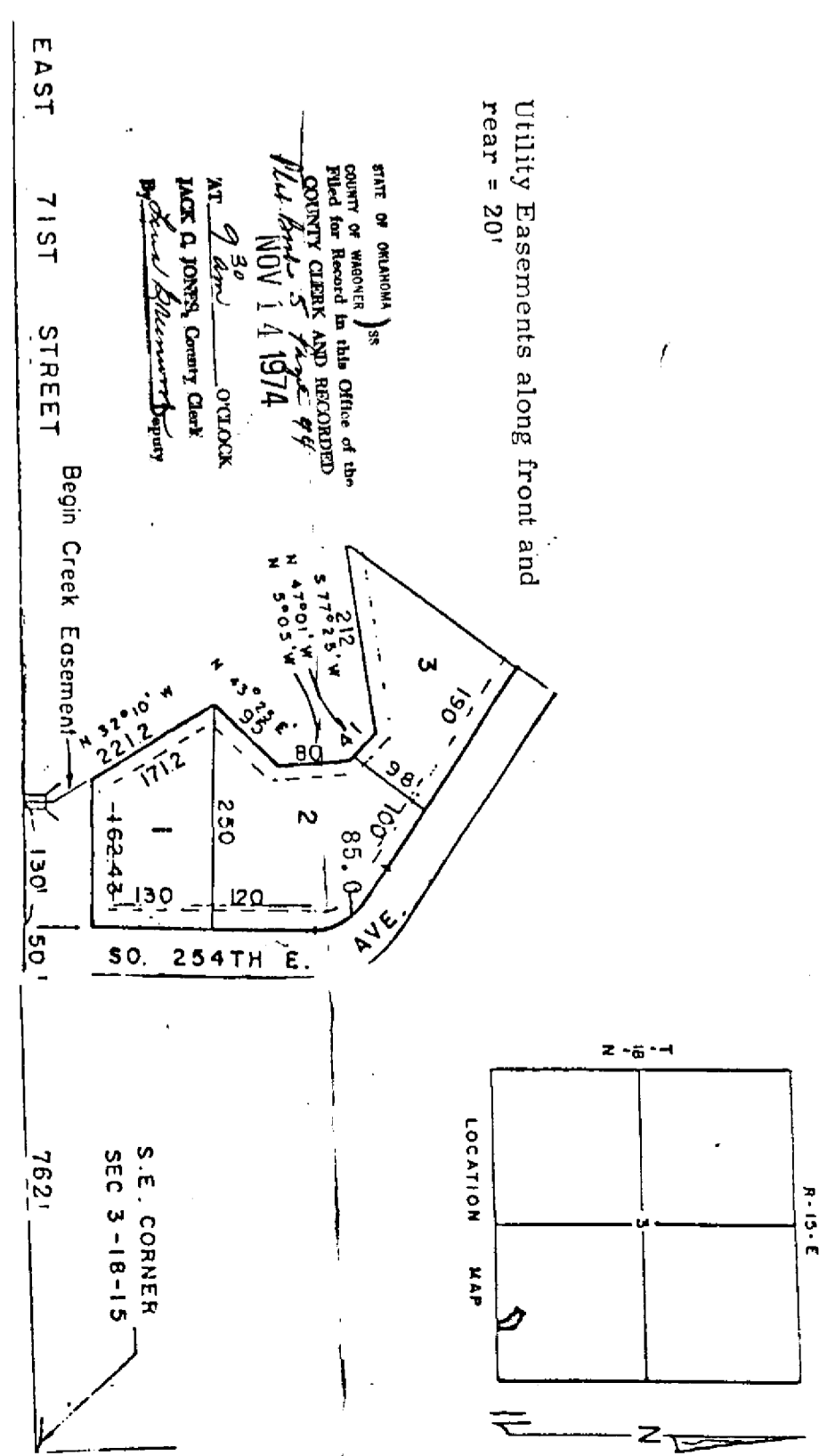
