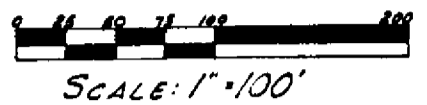


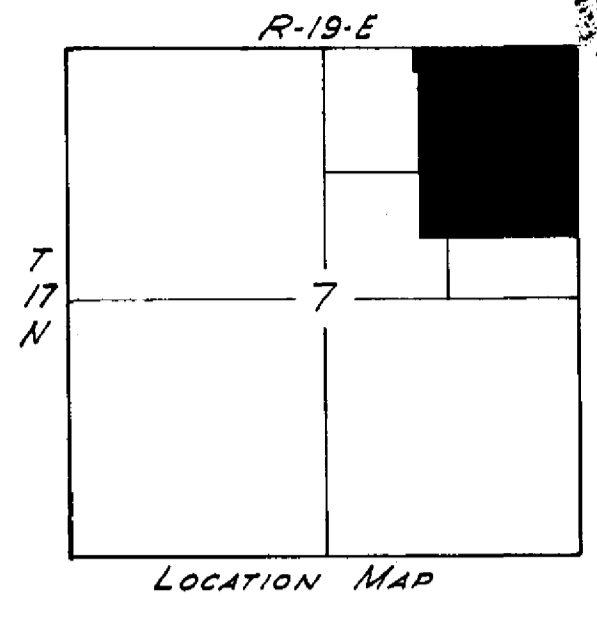
AMENDED PLAT OF CAREFREE HEIGHTS ADDITION WAGONER COUNTY, OKLAHOMA

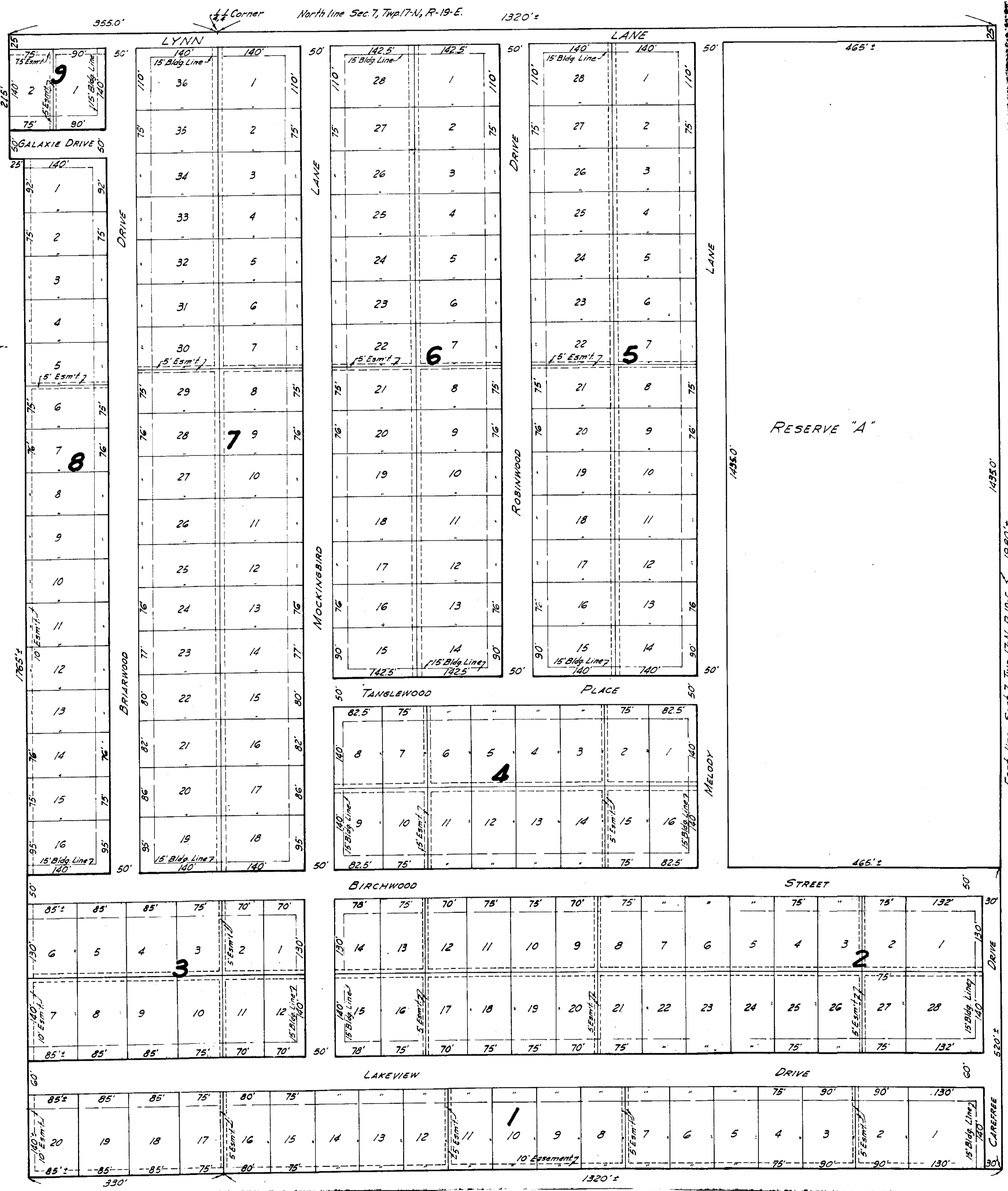
