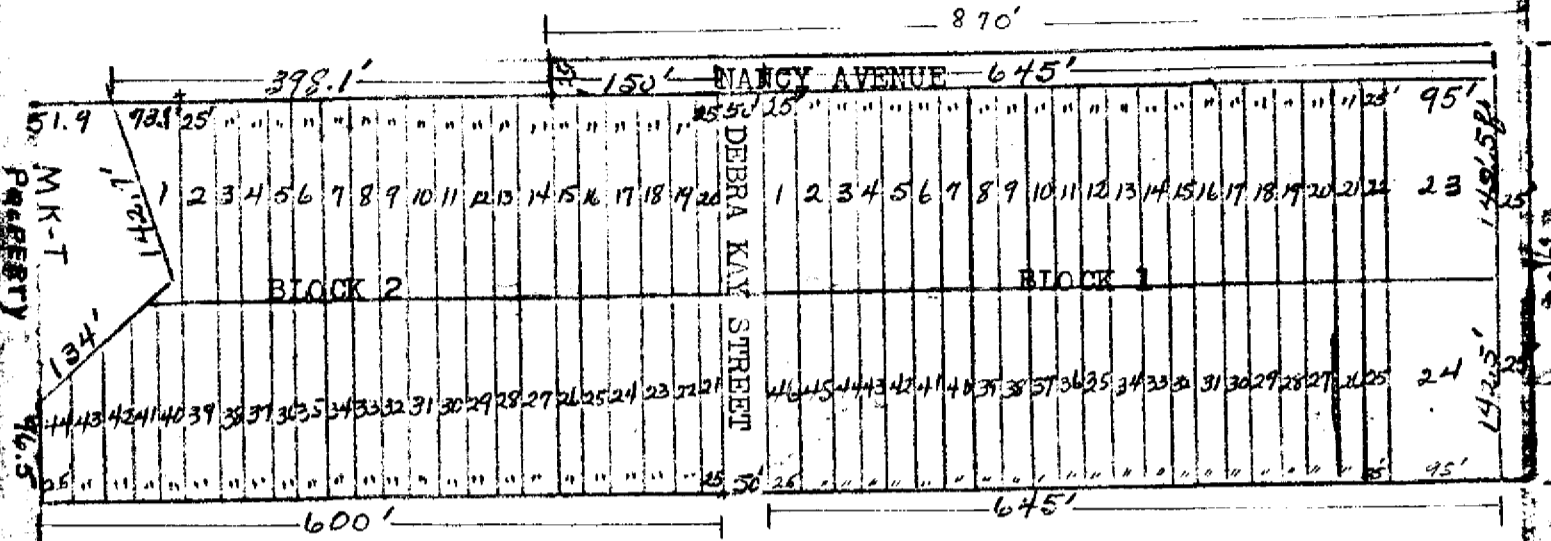

I, August Thieleke, County Surveyor of Wagoner County, Oklahoma, hereby certify that the above is a true and correct plat of the Cocke Addition to the Town of Coweta, Oklahoma, described as follows:

Beginning 290 feet South of the Northeast corner of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 18, Township 17 North, Range 16 East, Wagoner County, Oklahoma to the point of beginning; Thence West a distance of 870 feet parallel with the North line of the Southeast Quarter; Thence South 50 feet; Thence West a distance of 398.1 feet parallel with the North line of the Southeast Quarter to the East line of the M.K.&T. Railway property; Thence in a southeasterly direction a distance of 172.7' to the East point of M.K.&T. Railway property; Thence at right angle in the Southwesterly direction a distance of 134 feet along the M.K.&T. Railway property line to the West line of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ Quarter of Section 18; Thence South a distance of 96.5 feet along the West line of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ Quarter of Section 18; Thence East a distance of 1320 feet parallel with the South line of the Southeast Quarter of Section 18 to the East line of Section 18; Thence North 335 feet to the point of beginning.
