



Citizen Crime Report

This report form permits you to easily report a crime in which you are the victim.

This report will be reviewed by an investigator.

If any other information is needed the Wagoner County Sheriff's Office will contact you.

You may only use the citizen crime report if you are reporting one of the following crimes:

- * Larceny (under \$500.00)
- * Lost Property or supplemental loss for an existing report
- * Malicious Mischief / Vandalism
- * Harassing / Threatening / Obscene Phone Calls
- * County Misdemeanors

You may not use this report for domestic violence assault; hate crimes, or firearm complaints, burglaries, robberies, rapes etc. should be reported directly to the Wagoner County Sheriff's Office. This report cannot be used because physical evidence must be provided at the time of the report.

Bogus Check, Forged Check, and Embezzlement reports can be made in person at the Wagoner County Sheriff's Office at 307 E. Cherokee.
