



CORRECTIVE PLAT

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the plat of LAKE PARK ADDITION, an Addition to Wagoner, Wagoner County, Oklahoma, was filed in the office of the County Clerk of Wagoner County, Oklahoma, on March 9, 1954, recorded in Plat Book 1, Page 6-A, wherein Richard P. Wilcox, and P. B. DeWeese, appeared as the owners of a tract of land described in said plat as follows, to-wit:

The North 615' of the NW $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$  and the North 570' of the NE $\frac{1}{4}$  NW $\frac{1}{4}$  NW $\frac{1}{4}$  and the east 242.5' of the north 615' of the NW $\frac{1}{4}$  NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 8, Township 17 North, Range 19 East, Wagoner County, State of Oklahoma; and

WHEREAS, said plat was in error in the description of the property owned by said parties and included in said addition and said plat, and contained other obvious errors and omissions, including the point of reference of said plat to the Government survey of said section and certain references to the total combined distances between points; and

WHEREAS, it is the desire of said parties to file this corrective plat to correct such errors and omissions in the original plat.

NOW, THEREFORE, Richard P. Wilcox and P. B. DeWeese, as the owners of the property platted as LAKE PARK ADDITION to Wagoner, Wagoner County, Oklahoma, do file this corrective plat thereof to show the reference point of the plat of said addition to the Government survey of said section and to correct errors in total distances as reflected on this corrected plat and to correct the description of the property then owned by them, to read as follows:

The North 615' of the NW $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$  and the North 615' of the NE NW NW and the East 242.5' of the North 615' of the NW NW NW of Section 8, Township 17 North, Range 19 East, Wagoner County, State of Oklahoma.
