Deed of Dedication

Know all men by these Presents:-- That we, the North Muskogee Realty and Industrial Company and S.D. Slesper, some owners of the following described lands, situated in Wagoner County, Oklahoma, do wit:--

The Southeast quarter of the Southeast quarter of the Northwest quarter, and the Northeast quarter of the Northwest quarter of the Southwest quarter, and the West 1/2 of the NE 1/4 of the SW 1/4 of SW 1/4, and that part of the NW 1/4 of SW 1/4 of SW 1/4 lying East of River, and S 1/2 of SW 1/4 of SW 1/4 of NE, and the SW 1/4 of SE 1/4, and the East half and NW 1/4 of NE 1/4 of SE 1/4 of Section 20, as that part of W 1/2 of SE 1/4 of NE 1/4 lying North and East of river and Clinigan Creek, in Section 19, 20 in Township 16 North, Range 19 East.

do hereby dedicate to the Public use forever all of the streets, alleys and other public places shown on the plat of the said described lands, which said plat has been duly certified and acknowledged in the Office of the Register of Deeds of Wagoner County, Oklahoma on the 16th day of December, 1911, as the plat of the Townsite of North Muskogee, Oklahoma.

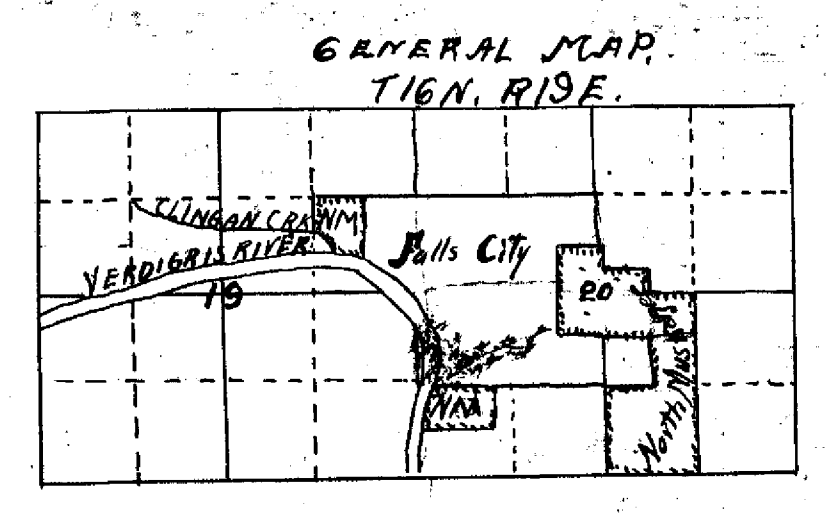
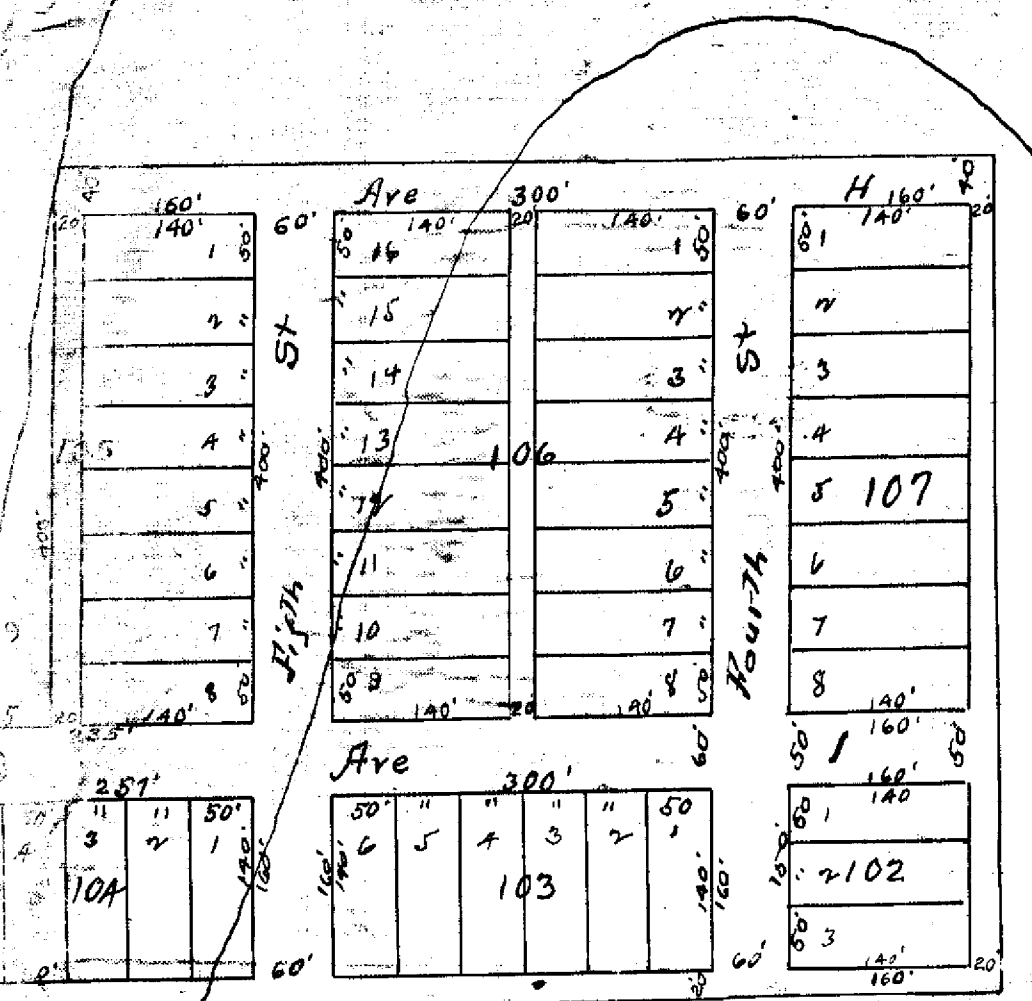
