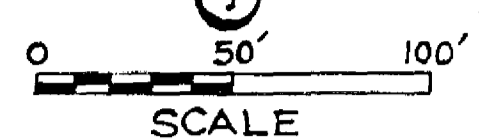

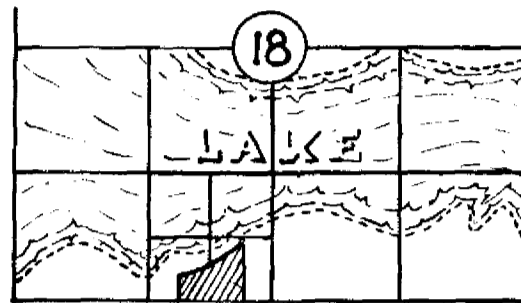
APPROX. SHORE LINE - 554
