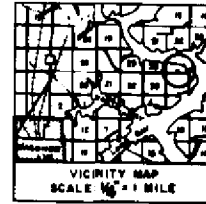

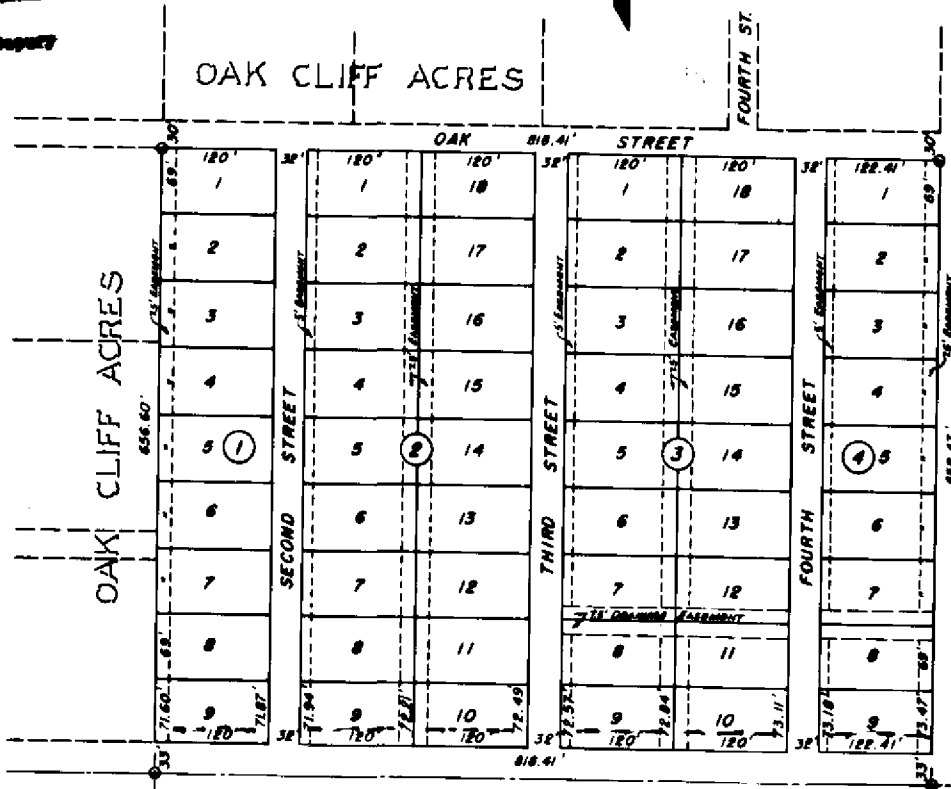

DEDICATION

KNOW ALL MEN BY THESE PRESENTS

That we the President and Secretary of Snug Harbor Village, Inc. an Oklahoma Corporation, do hereby certify that the Snug Harbor Village, Inc. is the owner and the only owner having any right, title or interest in the land described herein, and as shown on the annexed plat of Patrician Mobilehome Park, and that the plat represents a correct survey of the above described property made with our consent, and that the Owner hereby dedicates the roadways as shown on the plat for the ingress and egress of the owners of a lot, or lots, of said subdivision, their heirs and assigns, forever.

The Owner hereby further dedicates for public utilities, easements, and rights-of-way as required to serve the premises for the construction, maintenance, operation, repair, or removal of sanitary sewers or other necessary sewer facilities, electric, telephone, gas and water lines, either by erecting poles, wires, conduits, and pipes, and/or any and all facilities for the purposes stated above, with the right of ingress and egress upon said property.

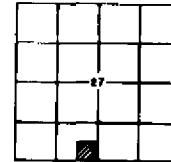
