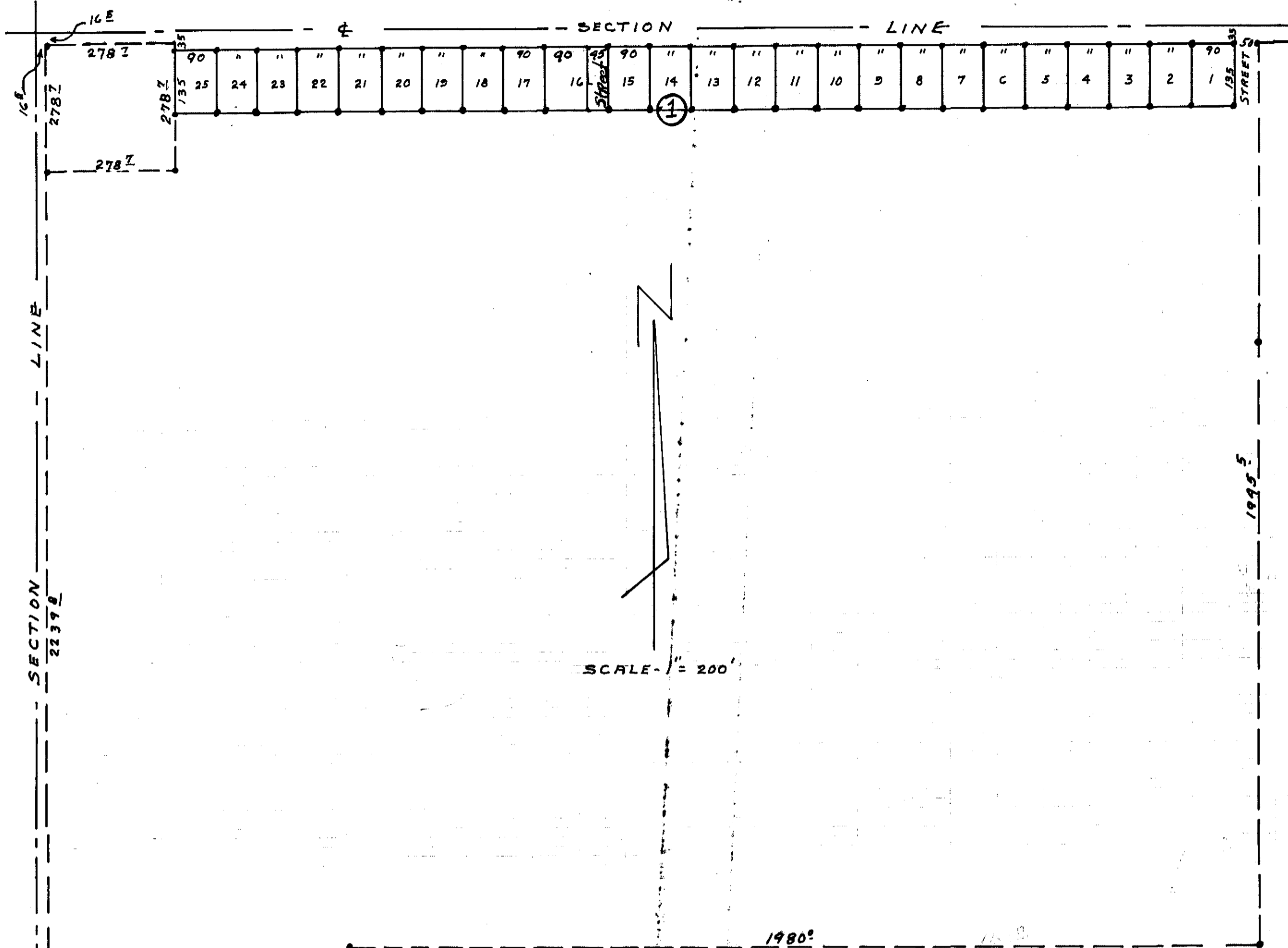


PRIMROSE SUBDIVISION

OWNERS CERTIFICATE & DEDICATION:

I, *Oliver P.
