


CERTIFICATE OF DEDICATION

FOR

LOTS 9 THRU 16, BLOCK 1; LOTS 6 THRU 22, BLOCK 2 and LOTS 12 THRU 20, BLOCK 3

ROLLING HILLS ADDITION

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS ROLLING HILLS DEVELOPMENT CO., an Oklahoma Corporation, is owner of the following described land in the County of Wagoner, State of Oklahoma, to-wit:

Beginning at a point, said point being 166.68 ft. East and 612.54 ft. South of the NW corner of Lot 8, Section 6, T-19-N, R-15-E, Wagoner County, Oklahoma; thence South 89° 27.2069' West a distance of 161.71 ft. to a point; thence N 0° 32.7931' West a distance of 34.28 ft. to a point; thence S 89° 27.2069' West a distance of 111.70 ft. to a point; thence S 0° 32.7931' East a distance of 2.13 ft. to a point; thence S 89° 27.2069' West a distance of 161.71 ft. to a point; thence S 0° 32.7931' East a distance of 629.09 ft. to a point; thence East 170.02 ft. to a point; thence along a curve to the left with a radius of 164.28 ft. a distance of 59.35 ft. to a point; thence N 69° 13.5891' East a distance of 94.71 ft. to a point; thence on a curve to the right with a radius of 164.28 ft. a distance of 59.35 ft. to a point; thence East a distance of 165.52 ft. to a point; thence North a distance of 99.72 ft. to a point; thence N 5° 46.5439' East a distance of 45.51 ft. to a point; thence N 0° 32.7931' West and parallel to the West line of Lot 8, Section 6, a distance of 394.76 ft. to the point of beginning, and containing 7.246 acres, more or less,

and has caused the above described land to be surveyed, staked, platted and subdivided into lots, blocks and streets, and have designated the same as LOTS 9 THRU 16, BLOCK 1; LOTS 6 THRU 22, BLOCK 2 AND LOTS 12 THRU 20, BLOCK 3, ROLLING HILLS ADDITION.

NOW, THEREFORE, the undersigned ROLLING HILLS DEVELOPMENT CO., an Oklahoma Corporation, does hereby dedicate for public use all of the streets as shown on said plat and does hereby guarantee the title to all of the land covered by said streets, and for the purpose of providing an orderly development of the above described real estate, and in order to provide adequate restrictive covenants for the mutual benefit of itself and its successors in title to the subdivisions of said land (hereinafter referred to as lots) the undersigned does hereby impose the following restrictions and reservations and create the following easements, which shall be binding upon it, its successors, and assigns.

THESE covenants are to run with the land and shall be binding on all parties and all persons claiming under them until February 10, 1986, at which time said covenants shall be automatically extended for successive periods of ten (10) years, unless by vote of a majority of the then owners of the lots it is agreed to change said covenants in whole or in part.

If the parties hereto, or its assigns, shall violate or attempt to violate any of the covenants herein, it shall be lawful for any other person or persons owning any real property situated in said development or subdivision to prosecute any proceedings at law or in equity against the parties or person or persons violating or attempting to violate any such covenant and either to prevent him or them from so doing or to recover damages or other dues for such violations. INVALIDATION of any one of these covenants by Judgment or Court Order shall in no wise affect any of the other provisions which shall remain in full force and effect.

- A. All lots in the Addition shall be known and described as residential lots; and shall be used for residential purposes only. No structures shall be erected, altered, placed or permitted to remain on any residential building plot other than a single family dwelling, and a private garage or carport, which shall be attached to the residence.
- B. No building shall be located nearer to the front lot line, nor nearer to the side street line, than the building lines shown on the Recorded Plat; and in any event, no building shall be located nearer than five (5) feet to any side lot line.
- C. No more than one residence or structure shall be erected on any lot as now platted.
- D. No business or trade shall be conducted on any lot, nor shall any noxious activity be carried on upon any lot, nor shall anything be done thereon which may be, or may become an annoyance or a nuisance to the neighborhood.
- E. No trailer, basement, tent, shack, garage, barn, or other outbuilding erected in this Addition shall at any time be used as a residence, either temporarily or permanently, nor shall any structure of a temporary nature or character be used as a residence.
- F. No dwelling shall be erected on any residential lot in the Addition, the ground floor of the main structure of which, exclusive of open porches and garages, in less than 850 square feet in area.
- G. No fence on any lot shall be more than six (6) feet in height, nor shall any fence on any lot be constructed forward of the main dwelling structure.
- H. No structure previously used shall be moved onto any lot in this Addition.
- I. The undersigned owner further dedicates to the public for public use forever the easements and right-of-way as shown and designated on the plat for the several purposes of constructing, maintaining, operating, repairing, replacing any and all public utilities including the storm and sanitary sewers, telephone lines, electric power lines and transformers, gas lines, and water lines, together with all fittings and equipment for each of such facilities and any other appurtenances thereto, with the right of ingress and egress upon said easements and rights-of-way for the uses and purposes aforesaid, together with similar rights in each and all of the streets shown on said plat; PROVIDED, HOWEVER, that the undersigned owner hereby reserves the right to construct, maintain, operate, lay and relay water lines and sewer lines together with the right of ingress and egress for such construction, maintenance, operation, laying and relaying, over across and along all of the public streets, alleys and easements shown in said plat, and/or sewer services to the area included in said plat and to any other areas.
