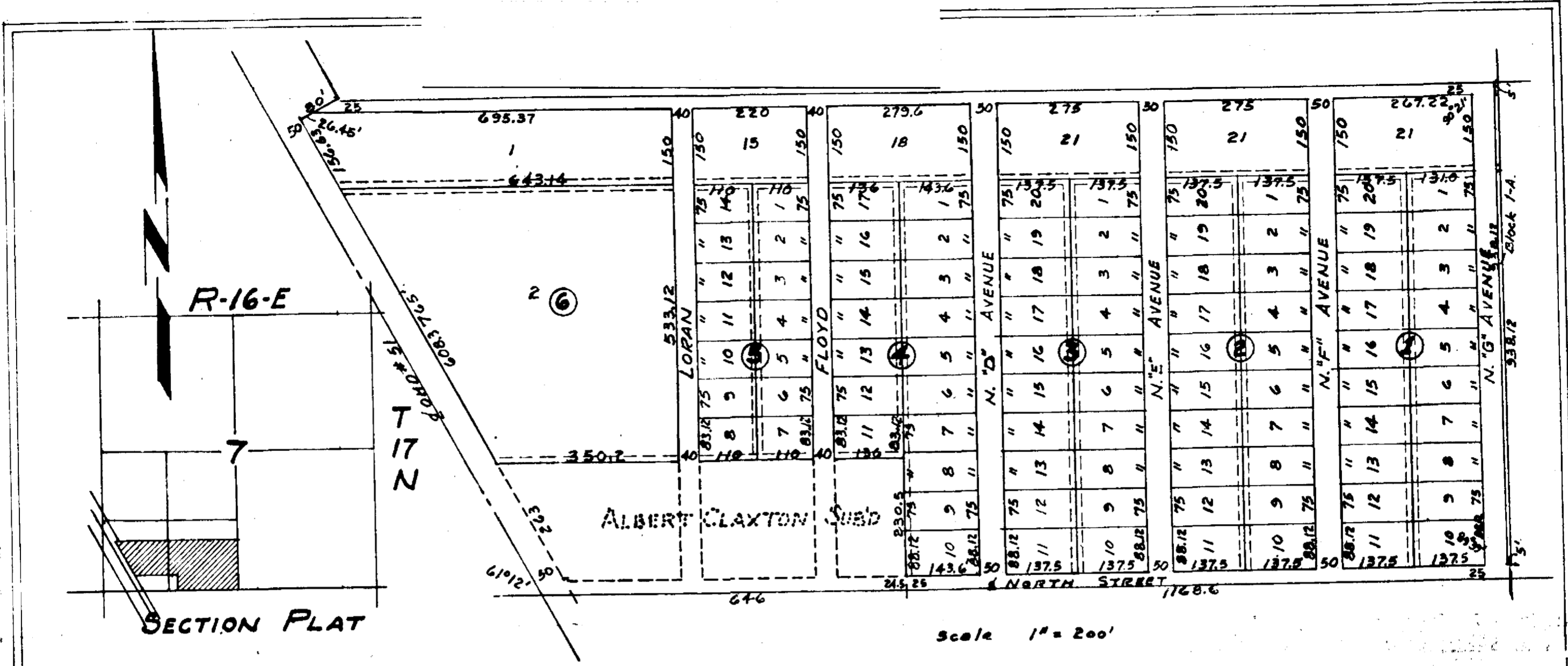

CERTIFICATE OF OWNERS:

Beginning at the SE corner of the SW/4 Section 7, T-17-N R-16-E, I.M. Thence West along the South section line 1168.6 feet. Thence North perpendicular to the section line 255 feet. Thence West and parallel with the South section line 786.2 feet to the Easterly Right-of-Way line of O.S.H. #51. Thence Northwesterly along said Right-of-Way 765 feet. Thence N 61° 24' W along said Right-of-Way 80 feet. Thence East and parallel with the South section line 2252.2 feet to the East line of SW/4, Thence South 963.12 feet to the point of beginning.
