


VICINITY MAP

LEGAL DESCRIPTION

The East 130 feet of the North 200 feet of the NE 1/4-SE 1/4-SE 1/4 of Section 19, Twp. 18 N., R. 19 E.
 And a tract in the NE 1/4-SE 1/4-SE 1/4 of Sec. 19, Twp. 18 N., R. 19 E., more particularly described as follows, to-wit: Beginning at the SE corner of said NE 1/4-SE 1/4-SE 1/4, thence North along the East line of said NE 1/4-SE 1/4-SE 1/4 a distance of 360 feet, thence West a distance of 228.4 feet to the Easterly Right-of-way line of a County road, thence Southerly along said Easterly right-of-way a distance of 360.65 feet, to a point on the South line of said NE 1/4-SE 1/4-SE 1/4, thence East along said South line a distance of 238.4 feet to the point of beginning.
 And the South 360 feet of the NW 1/4-SW 1/4-SW 1/4 of Section 20, Twp. 18 N., R. 19 E.
 And a tract in the SW 1/4-NW 1/4-SW 1/4 of Section 20, Twp. 18 N., R. 19 E., more particularly described as follows, to-wit: Beginning at the SE corner of said SW 1/4-NW 1/4-SW 1/4, thence North along the East line of said SW 1/4-NW 1/4-SW 1/4 a distance of 389.9 feet, thence S. 86°-32' W. a distance of 160.15 feet, thence South, parallel with the East line, a distance of 382.05 feet, to a point on the South line of said SW 1/4-NW 1/4-SW 1/4, thence East along said South line a distance of 160 feet to the point of beginning.
 And the East 160 feet of the North 300 feet of the NW 1/4-SW 1/4-SW 1/4 of Section 20, Twp. 18 N., R. 19 E.


