O'Neal R. Gillispie v. Estes Express Lines Inc. & New Hampshire Ins. Co., File #CM2014-03399K

After hearing oral arguments on September 15, 2017, the Commission took preliminary action to remand the Administrative Law Judge's order for specific findings related to Claimant's PTD tatus and instructed Commission Counsel or other staff member to draft a proposed order to that effect. A
