2. Request to Release Security Deposit for Resers Fine Foods Inc., fka Vaughan Foods Inc., Own Risk Permit #19675 and Possible Action to Approve Request

Vaughan Foods, Inc. ("the Company"), own risk permit #19675, was a self-insured employer through the Own Risk program from January 1, 2005 to February 1, 2011. The company was purchased by Resers Fine Foods Inc. on September 16, 2011. The Commission currently holds a \$100,000 surety bond issued by Travelers Casualty & Surety Co. as a security deposit. The Company has petitioned the Commission to release its collateral in full.

Resers Fine Foods Inc. fka Vaughan Foods Inc. has complied with Commission Rule 810:25-9-19.

3. Request to Release Security Deposit for HCA Inc., Own Risk Permit #18760 and Possible Action to Approve Request

HCA Healthcare fka HCA Inc. ("the Company"), own risk permit #18760, left the self-insured Own Risk program on December 31, 1997. The commission currently holds a \$100,000.00

surety bond issued by Westchester Fire Insurance Company as a security deposit. They have petitioned the Commission to release their collateral in full.

HCA Inc. has complied with Commission Rule 810:25-9-19.

4. Discussion and Possible Action to Adopt Proposed Draft Administrative Rules

The Commission has proposed changes to its current permanent administrative rules, available online at https://www.ok.gov/wcc/Legal/Governing_Documents/index.html. The Commission's Notices of Rulemaking Intent were published in the Oklahoma Register on January 17, 2023, and a comment period in excess of thirty days was provided from January 17 to March 16, 2023. Comments were solicited via regular mail, email, and at a public hearing.

Discussion and Possible Action to Adopt OMES Progressive Discipline Standards as WCC Progressive Discipline Policy
