#### 1. <u>Comments from the Public Regarding Proposed Emergency Rules and Forms</u>

The Commission will hear public comments regarding proposed emergency rules and forms pertaining to the Oklahoma Legislature's enactment of SB1249 creating the Affidavit of Exempt Status (in lieu of a Certificate of Noncoverage) and Cancellation of an Affidavit of Exempt Status.

Title 85A O.S. § 22 provides before the adoption, amendment or modification of any rule or form, the Commission shall give thirty (30) days' notice of its intended action and provide an opportunity for public comment. The Commission provided notice of the intent to consider proposed emergency rules and forms on June 12, 2018.

#### 2. Discussion and Consideration of Adoption of Proposed Emergency Rules

The Commission will consider adopting proposed emergency rules to amend the following sections of the Commission Permanent Rules:

If adopted, the emergency rules will be submitted to the Governor for approval.
