DEATH BENEFITS

Administrative Workers' Compensation Act, 85A O.S., §47(C) For Deaths Occurring During the Period of November 1, 2015 Through October 31, 2016

Weekly death benefits for beneficiaries subject to the Administrative Workers' Compensation Act are computed as percentages of the deceased's average weekly wage (AWW), which shall be taken as not more than the State Average Weekly Wage (SAWW).

The following chart is an **EXAMPLE**. It represents the aggregate weekly income benefits payable to all beneficiaries of a deceased worker whose AWW equals or exceeds the SAWW of \$841.90.
