The members of the Workers' Compensation Commission for the State of Oklahoma met at 1915 N. Stiles Ave., Oklahoma City, Oklahoma, on JANURY 15, 2020.

- **7a. Self-Insurance Guaranty Fund Report.** Discussion and possible action as to new procedure to implement statutory change. Effective November 1, 2019, 85A O.S. Section 98 requires the use of the **net fund balance** technique rather than the current **cash fund balance** method to initiate an assessment of the Self-Insureds. Richard Fisher will analyze and discuss the net fund balance amount for the 675/705 Account.
- **7b. Self-Insurance Guaranty Fund Report** of claims arising pursuant to statutory authority of the Self-Insurance Guaranty Fund Board for the private employers approved to participate in the self-insurance program designated by account number of 675 and residual account 705. There will be a general report of the Third Party Administrator including a financial summary, discussion and possible action by the Board.
- **7c. Trust Cases Report** Discussion and possible action as to new procedure to implement statutory changes. Effective November 1, 2018, 85A O.S. Section 99 allows the transfer of "excess proceeds" 701 account balances to the Self-Insured Guaranty Fund account 675/705. Mr. Fisher will report on the claims analysis of older 701 accounts, including but not limited to, Healthcor Holdings, Inc., Builders Transport, Inc., and Acme Fence & Iron, Inc. Mr. Fisher will report his findings and make recommendations to transfer the funds to the **Self-Insurance Guaranty Fund**.
