WCC & CEC Tulsa Office Move January 3-14, 2022

In January, the WCC & CEC Tulsa offices will begin the move to 201 West 5th Street. Tulsa dockets <u>will</u> <u>not be set</u> for the weeks of January 3rd through January 14th. The WCC and CEC offices will be located on the 5th floor of the 201 West 5th Street Building. Until first floor construction is completed, expect to pass through building security upon exiting the elevator on the 5th floor.

Parking

Claimant Parking- We are thankful that OMES and the building landlord (The Commission of the Land Office) has provided cost free parking for claimants. The 201 West 5th Street building will have parking spots **reserved for claimants** and public guests of the other agencies who share the building. Claimants will take a ticket upon entry into the parking lot and may validate it at the 1st floor lobby kiosk before they exit the building to avoid the parking charge.

Attorney Parking- Parking is limited, and in order to ensure adequate parking for claimants and guests of other agencies in the building, attorneys will not have access to the building's parking lot between the hours of 8:00 a.m. to 12:00 p.m. Monday through Thursday. Attorneys may **pay to park** in the lot for intermittent business outside of those hours. There are several parking garages with daily and monthly rates close to the new location. Please plan for parking before cases resume the week of January 17, 2022.
