The Commission will discuss and consider renewing a state contract between the Commission and Standley Systems, LLC for the lease and maintenance cost based upon type of copies for 36 months effective April 1, 2020. The total cost of the 36-month contract is \$20,113.92 (\$6,704.64 per year).
