## MINUTES OF THE OPEN MEETING OF THE BOARD September 7, 2012

An open meeting of the Board of Examiners of Psychologists was held at 9:00 a.m. on Friday, September 7, 2012 at the Attorney General's Office, 313 Northeast 21<sup>st</sup> Street, Oklahoma City, Oklahoma.
