



## **MINUTES OF THE MEETING OF THE BOARD September 20, 2013**

A Meeting of the Board of Examiners of Psychologists was held at 9:00a.m. on Friday, August 23, 2013, at the Attorney General's Office, 313 NE 21<sup>st</sup> Street, Oklahoma City, OK.

In attendance were M. Cohn, Ph.D., Chair of the Board; S. Beasley, Jr., Ph.D., Vice-Chair of the Board; R. Hand, Ph.D., Member of the Board; P. Fischer, Ph.D., Member of the Board; B. Harris, Member of the Board; T. Bourdeau, Ph.D., Member of the Board; M. Lane, Assistant Attorney General; T. Rose, Executive Officer of the Board.

Members not present: S. Turner, Member of the Board.

### **Announcement and Introduction:**

Dr. Cohn announced that a quorum was present to conduct business. She confirmed with Ms. Rose that the meeting was filed with the Secretary of State and the agenda was posted in accordance with the Open Meeting Act.

### **Minutes:**

The Board reviewed the minutes of the August 23, 2013 meeting presented by Ms. Rose. *Dr. Beasley made the motion to approve the minutes of the August 23, 2013 meeting. Dr. Fischer seconded the motion and the motion passed. Hand, Fischer, Beasley and Cohn voted for the motion. Bourdeau and Harris abstained from the vote.*

### **Status of Current Request for Inquiries:**

**RFI 12-9, RFI 12-10 and RFI 12-12;** pending the outcome of BC 12-20.  
**RFI 13-2;** report at the October 11, 2013 meeting.

### **Probable Cause Committee Summaries and Recommendations to the Board:**

**RFI 13-1;** Dr. Fischer reported that the PCC reviewed the investigative report and that while the report written was of limited utility, the committee did not find that there were any ethical principles or codes of conduct violated. The committee recommended the psychologists agree to one of two things: 1) the psychologist abstain from conducting capacity evaluations in the future or 2) agree to not conduct any further evaluations unless she undergoes specialized training and remediation. The Psychologist agreed she will not conduct any type of capacity evaluation in the future.

*Dr. Fischer made a motion to approve the PCC recommendation to dismiss and close the Request for Inquiry RFI 13-1 with no ethical violation, with the agreement to not conduct any capacity evaluations in the future. Dr. Beasley seconded the motion and the motion passed. Hand, Fischer, Beasley, Bourdeau, Harris and Cohn voted for the motion.*

**Reports of Miscellaneous Complaint Issues, Orders and Tutorials:**

**BC 10-6 Palmer;** Ms. Rose reported that no clientele list was received.

*Dr. Hand made a motion to accept Dr. Palmer's clientele list as presented. Dr. Bourdeau seconded the motion and the motion passed. Hand, Fischer, Beasley, Bourdeau, Harris and Cohn voted for the motion.*

**BC 11-3 Tedder;** no report.

**BC 12-4 Neal;** Ms. Lane reported on Dr. Neal's appeal with the District Court. Ms. Lane provided the scheduling order to the Board. Dr. Neal has to file a brief on or before October 1, 2013 and the Board will need to provide a response on or before November 1, 2013. Ms. Lane or Ms. Savage will prepare the response.

**BC 12-7 Turnock;** Ms. Rose provided an update that Dr. Turnock submitted payment toward the balance of his fine.

**BC 12-11 Martin;** The Board reviewed Dr. Martin's request for Dr. Susan McCurdy to provide psychotherapy as stated in the Consent Order.

*Dr. Hand made a motion to approve Dr. Martin's request for Dr. McCurdy to provide psychotherapy. Dr. Beasley seconded the motion and the motion passed. Hand, Fischer, Beasley, Bourdeau, Harris and Cohn voted for the motion.*

**BC12-20 Talley;** Ms. Rose provided update that Dr. Talley remains in compliance.

**UC13-1;** The Board reviewed the information provided by Ms. Rose regarding misrepresentation. The Board referred the information to Ms. Savage for review and to provide feedback at the October 2013 meeting.

*Dr. Hand made a motion to approve the new Jurisprudence Examination as presented. Dr. Cohn seconded the motion and the motion passed. Hand, Fischer, Bourdeau and Cohn voted for the motion. Beasley and Harris were absent from the vote.*

*Dr. Hand made a motion to accept the Jurisprudence Examination Committee's recommendation to discontinue the practice of providing Jurisprudence Exam feedback at the end of Oral Examinations. Dr. Bourdeau seconded the motion and the motion passed. Hand, Fischer, Bourdeau and Cohn voted for the motion. Beasley and Harris were absent from the vote.*

Dr. Hand suggested the Board develop a system of providing feedback to the Jurisprudence Examinees who miss a substantial portion of the Jurisprudence Critical items (5 or more) or score below 80%. The feedback should be provided in person by a Board member.

*Dr. Bourdeau made a motion to create a temporary plan to offer times for examinees to meet with a Board member and review the critical items missed on the Jurisprudence Examination. Dr. Hand seconded the motion and the motion passed. Hand, Fischer, Bourdeau and Cohn voted for the motion. Beasley and Harris were absent from the vote.*

**PPUS/IPUS extensions form/policies;**

Dr. Bourdeau and Ms. Rose will provide the Board revised forms at the October 2013 meeting.

**Discussion of APA approved doctoral programs requirements;** *no action.*
